

## Terms and Conditions

Applicants participating in all Global Dreamer Foundation's educational programs agree that the information provided on all application forms is accurate and complete, to the best of your knowledge.

Applicants agree to Global Dreamer Foundation processing personal data contained in the application form, or other data that Global Dreamer Foundation may obtain from the students, students' relatives, universities, or organizations whilst applying for admission.

Applicants agree to the processing of such data for any purpose connected to my studies, or my health and safety whilst on university's premises or for any other legitimate purpose.

Applicants agree to submit all required documents, forms, and payments by the deadlines communicated by Global Dreamer Foundation. Any delay or failure to provide required materials may result in application delay, withdrawal, or additional fees, for which Global Dreamer Foundation shall not be held responsible.

Applicants acknowledge that Global Dreamer Foundation reserves the right to refuse admission, terminate an applicant's attendance, and deduct all service fees and tuition should it be discovered that he/she has made a false statement or has omitted significant information. Applicants acknowledge that universities may conduct background verification or authenticity checks on any submitted materials. Any falsification may result in immediate cancellation without refund.

Global Dreamer Foundation reserves the right to terminate services without refund if the applicant engages in abusive behavior, harassment, threats, defamation, or any other conduct deemed inappropriate toward our staff, university personnel, or other students. Global Dreamer Foundation further reserves the right to pursue additional legal action if necessary.

All official communications must be in writing via email. Verbal statements made by staff shall not be considered binding.

Personal Statement or Essay is a vital part of the application and some universities require the applicant to submit it. The use of AI-generated content in your statement of purpose is strictly prohibited. Using AI-generated content undermines the integrity of your unique voice and narrative. We take the use of AI-generated tools and content seriously to ensure a fair and equitable evaluation of all applicants. Your application will be immediately rejected and no

refund will be issued if you use AI-generated content including ChatGPT, Google Translation, etc.

Before submitting the application or purchasing the services, the Applicants acknowledge that you have carefully read the Terms and Conditions and understand that you will need to pay the selected service fee. The \$500 down payment (included in the total service fees) is non-refundable if offered admission, and will be fully refunded if not admitted to the programs that have an admission guarantee\*.

Applicants have reviewed and agreed to accept any legal or campus requirements (minimum unit requirements, minimum GPA requirements, visa requirements, etc.) enforced by each university and/or government agency. Applicants will be responsible for any violation of the above terms and conditions.

Global Dreamer Foundation does not guarantee the student assignment to any specific room, facility, or with specific roommate(s) during the term of this Agreement. Room availability and type are subject to change. The student agrees to adhere to the rules outlined in the housing contract. Check-in dates are normally on Sundays prior to the program start date, and check-out dates are on Fridays at the conclusion of the program. These dates are established by the university and cannot change unless both parties have other written agreement.

Global Dreamer Foundation is not an agent, representative, or employee of any university. Final admissions decisions, housing assignments, course offerings, visa issuance, and any related administrative processes are made solely by the respective universities or government agencies.

The student acknowledges and agrees that Global Dreamer Foundation may engage third-party contractors to deliver the services. With respect to housing, insurance, and airport pickup services, the registration center's responsibility is limited to facilitating service arrangements. The registration center shall not be held liable for any personal or financial liabilities arising from these services, including but not limited to conditions of on-campus housing, personal health conditions, injuries, illnesses, visa delays or rejections. The student bears the responsibility of familiarizing themselves with the respective housing options and insurance policies and independently contacting the appropriate service providers, such as the on-campus housing office and health insurance provider.

Students agree to comply with all applicable laws, policies, and regulations established by the foreign country, the university, and any service providers, including but not limited to housing and transportation providers.

In the event of any inconsistency or discrepancy between the English version of these Terms and Conditions and any translated version, the English version shall prevail.

## **Cancellation & Refund Policies**

Global Dreamer Foundation strives to provide the best possible services to our applicants and clients. All Applicants purchasing our service packages are subject to the below cancellation and refund policies.

### **Admission Decision**

Global Dreamer provides educational programs that are highly competitive and usually only take a certain number of students per semester around the globe. Applicants will have a higher chance of being admitted if submit applications sooner. While we will assist during the process, admission is NOT guaranteed, and all admissions decisions are final.

### **\*Admission Guarantee**

Admission is guaranteed on selected programs only and please consult the consultants for the most up-to-date information, all guarantees must be in writing.

### **Programs Cancelled or Rescheduled by the University**

In the event of a public health emergency or other exigent circumstances, the Registration Center or the universities reserve the right, at their sole discretion, to conduct the event in a virtual format. By registering for an in-person event, registrants consent to participate in either an in-person or virtual setting. The universities retain the authority to cancel or reschedule any event for any reason. Registrants will be provided with as much notice as is reasonably practicable under the circumstances, along with distinct refund policies.

Global Dreamer will refund 100% of service fees, less \$500 processing fees, if the entire program is canceled by the University. If The University reschedules an event to a date when the registrant is unable to attend, it will refund 100% of the registrant's tuition and service fees, except the \$500 down payment, provided that the registrant requests the refund within 30 (thirty) days of Global Dreamer and the university communicating the new date; otherwise, the refund reschedule below (for registrant cancellations) applies.

Global Dreamer Foundation shall not be liable for any delay, interruption, or cancellation of services caused by events beyond reasonable control, including but not limited to public health

emergencies, natural disasters, government policy changes, visa suspension, strikes, or war. In such cases, refund decisions will follow the standard refund policy.

### **For All programs and Service Packages**

Global Dreamer provides a variety of service packages for applicants with comprehensive features. One service package is only valid for one application unless both parties reach a mutual agreement in writing. All services need a high level of expertise and resources to ensure applicants have a positive experience. Therefore, In any case, if the applicants decide to withdraw or cancel the program, the applicant agrees to the below refund policies, no matter whether the services have been delivered:

- Refund requested > 180 days prior to start date = 100% refund
- Refund requested  $\leq$  180 days and > 150 days prior to start date = 50% refund
- Refund requested  $\leq$  150 days and > 120 days prior to start date = 25% refund
- Refund requested  $\leq$  120 days prior to start date = No refund
- For hybrid events or training the "start date" is defined as the date of the first session, whether virtual or in-person
- Approved refunds will be processed within 30–45 business days.

The service does not guarantee that the student will pass the visa interview or be granted entry by Customs and Border Protection. No refund will be issued if the student is denied entry by Customs and Border Protection. If the student's visa application is denied by the embassy, the Registration Center agrees to refund the student for any undelivered or unpaid services, less the \$500 down payment, services that have been delivered or paid cannot be refunded.

In any case if the applicant is rejected by the embassy for the visa application AND has purchased the 100% Visa Guarantee service, Global Dreamer agrees to refund 100% of the tuition and service fees.

Service fees, university tuition, and housing fees are subject to change based on the policies of the university or third-party providers. Any increase imposed by such third parties will be the responsibility of the applicant.

Please note that service package does not include the following, unless otherwise mutually agreed on in writing:

- Personal expenses, travel arrangements, or emergency support
- Any university-imposed fees, late submission fees, or document evaluation fees
- Visa fee, SEVIS fee, courier/postal fees, medical insurance, or any government-related charges

To the maximum extent permitted by law, Global Dreamer Foundation's total liability shall not exceed the total amount of service fees paid by the applicant.

### 条款与条件 (中文参考译本)

申请人参与 Global Dreamer Foundation 的所有教育项目, 即表示其确认并保证在所有申请表中所提供的信息均真实、准确且完整。

申请人同意 Global Dreamer Foundation 在申请过程中处理申请表中的个人信息, 以及从学生、学生家属、大学或相关机构获取的其他资料。申请人同意 Global Dreamer Foundation 可将上述资料用于与其学习、健康安全或其他正当目的相关的事项。

申请人应按 Global Dreamer Foundation 通知的截止日期提交所有所需文件、表格及费用。任何延迟或未按要求的材料可能导致申请延迟、撤回或产生额外费用, Global Dreamer Foundation 对此不承担责任。

申请人确认并同意: 若发现其提供虚假信息或遗漏重大资料, Global Dreamer Foundation 有权拒绝申请、终止服务, 并扣除所有服务费及学费。同时, 申请人也理解大学可能会对所提交材料进行真实性或背景审查, 任何造假行为将导致立即取消申请且不予退款。

若申请人对 Global Dreamer Foundation 工作人员、大学人员或其他学生出现辱骂、骚扰、威胁、诽谤或任何不当行为, Global Dreamer Foundation 保留立即终止服务且不退款的权利, 并保留进一步采取法律行动的权利。

## 取消与退款政策（中文参考译本）

Global Dreamer Foundation 致力于为申请人提供优质服务。所有申请人购买服务套餐后即视为同意以下退款政策：

### 录取决定

Global Dreamer Foundation 的合作项目竞争激烈，每学期全球仅录取一定名额。越早提交申请，录取机会越高。Global Dreamer Foundation 将提供协助，但不保证录取，所有录取结果均为最终决定。

### 录取保证说明

部分项目提供录取保证，请咨询顾问以获取最新信息。如有保证须以书面约定为准。

### 因大学取消或改期

如因公共卫生或紧急状况，注册中心或大学有权将线下活动改为线上形式。报名即表示申请人理解并接受活动可能以线上或线下方式进行。大学保留取消或改期的权利。

若大学取消项目，Global Dreamer Foundation 将退还 100% 服务费，但会扣除 500 美元处理费。

若大学改期且申请人无法参加，只要申请人于收到新日期后 30 天内提出申请，可退还 100% 学费与服务费（不含 500 美元订金）。

#### 不可抗力

因不可抗力（公共卫生、自然灾害、政策变动、签证暂停、战争等）导致项目延迟、中断或取消，将按标准退款政策执行。

#### 通用退款政策（适用于所有项目）

按项目开始日期计算：

- 提前超过 180 天提出退款：退 100%
- 150–180 天：退 50%
- 120–150 天：退 25%
- 少于 120 天：不退款

退款将在 30–45 个工作日内处理。

Global Dreamer Foundation 不保证签证一定通过或海关一定放行。若被海关拒绝入境，不予退款。若大使馆拒签，注册中心将退还未提供或未支付的部分服务费用，但 500 美元订金和已发生费用部分无法退还。
